

TREASURER'S REPORT

Year Ended April 30, 2019



The fiscal year end of the Ontario Minor Hockey Association (OMHA) is April 30, 2019. Audited financial statements were issued by MNP LLP, with an unqualified auditor's report.

EXECUTIVE SUMMARY

The Association experienced a very difficult financial situation during this past year. From June 1, 2018 to November 30, 2018, a former-employee of the Association used the online banking platform to fraudulently transfer \$2,365,934 in cash to personal credit cards. Once this fraudulent activity was discovered executive director Ian Taylor immediately responded by terminating the individual's employment and revised the terms and controls over banking arrangements. It is unknown whether the Association will realize recovery of these lost funds. As a result of this loss a portion of the Association reserve funds were transferred to the General fund to finance ongoing operations. I am pleased to report that the Association has continued to operate in a fiscally responsible manner while still providing our high quality programs and continues to be a financially sound organization with strong reserve funds.

Highlights from this year's results:

- We administered approximately 114,000 teams, players and team officials.
- We would like to thank all of our sponsors and also the Marketing and Communications team for their continued support and efforts.
- The clinics and programs are still a very robust part of the OMHA. We thank our Development team and our regional executives for their stewardship of the educational process at the OMHA.
- We thank our Executive Director, Ian Taylor, with help from our Finance Manager, Svetlana Mardari for managing and prioritizing our office and administrative duties to ensure our operations flow continuously and effectively throughout the year.

The Association is very fortunate to have many valued and constant donors and volunteers who provide us with donated products and services that are not reflected in the audited financial statements. Without contributions many of our events would just not be affordable, so we thank all our donors and volunteers for their generosity.
